#### **Privacy Notice**

All personal data within this form will be treated as confidential and will be processed by Debison Albie Ltd trading as Woodland Outdoor Kindergartens in order to comply with our legal obligations in line with General Data Protection Regulation (GDPR). This form and the personal data it contains will be stored electronically within the UK using cloud based software including Office 365 email, Famly Nursery Management and Learning Journals. Names and contact details will also be stored on password protected mobile telephones. All personal data will be retained for a maximum period of 7 years. During the course of the day staff routinely record children's experiences by taking photographs/video clips. These photos are also displayed within our indoor premises. This is a routine practice and so we don't ask for your express consent to do this. All photos are retained for a maximum period of 7 years.

# Registration Fee

For children starting at the Kindergarten who will be accessing **BOTH funded hours and privately paid for hours**, a non-refundable (see exceptions below) registration fee of £75 is charged to secure a place at the kindergarten. In return, when your child begins their placement, they will receive their own personal Woodland Outdoor Kindergarten's Deuter rucksack, Kindergarten waterproof jacket and dungarees. This equipment will belong to you (children will be provided with welly boots on a daily basis as required).

For 2-3 year old enrolments (South Side only), there is a £75 registration fee.

Where chargeable, we request that the £75 registration fee is paid at the time of enrolment. The fee is payable by bank transfer to Debison Albie Ltd, sort code 83-04-25, account number 10179770. Please quote your child's full name and site enrolling at (west/south) as a reference.

The registration fee will be refunded on request under the following circumstances:

- Your child is on the waiting list for a place and a place is not offered within a reasonable timescale e.g. before your child starts school.
- Your circumstances change and you no longer require the place, please note you must provide at least 8 week's written notice prior to your child's requested start date in order for the fee to be refunded.

### **Start Date**

If, after enrolment, you require to delay your child's advised start date please note that Woodland Outdoor Kindergartens can only guarantee to accommodate a delay in start date by a maximum of one month. If you request to delay your child's start date by more than one month this will be accommodated where possible. If your request for a longer delay to your start date cannot be

accommodated, Woodland Outdoor Kindergartens reserves the right to amend your child's start date to the following August.

# Payment of Fees

Fees are payable one month in advance by the 5<sup>th</sup> of each month by standing order and are non-refundable in the event of your child's absence. Fees are normally subject to annual review but may be revised at other times with reasonable notice. Woodland Outdoor Kindergartens reserves the right to charge 5% of the monthly fee for late payment of fees and your child's placement may be suspended pending full payment.

#### Attendance

Extra sessions must be paid for in advance. If you wish to decrease your child's attendance, we require one month's written notice.

#### **Termination Notice**

One month's notice in writing, or payment in lieu of notice, must be given if you wish to withdraw your child from the Kindergarten.

Due to the unique 'no walls' nature of our outdoor kindergarten, we may not be able to provide placements to children identified as a 'flight risk'. If a child is identified as having the potential to leave camp unaccompanied, parents will be advised that an outdoor nursery with no physical boundaries may not be the best option for their child's Early Learning and Childcare and will be encouraged to look for alternative provision. In the event that the behaviour escalates, WOK may terminate the placement with immediate effect on the grounds that the Kindergarten is not an appropriate setting for the child in regard to their wellbeing.

#### **Start and Finish Times**

Woodland Outdoor Kindergartens operates between the hours of 8 am to 6pm. Parents/carers must inform the nursery by 9am if their child is not attending the nursery that day, otherwise the nursery will be delayed leaving for the woodland as staff will assume a problem exists and will make attempts to contact the parents/carers or emergency contacts.

Drop off and pick up times are between 8am and 9am and 5pm and 6pm respectively. We request that children are dropped off no later than 9am to assist with the smooth running of the transportation of staff and children to the woodland. If parents/carers are running late they must inform the nursery as soon as possible and staff will make arrangements, where possible, to delay

their child's group and/or in exceptional circumstances will agree an alternative drop-off point within the park.

Children cannot be cared for out with the normal nursery hours, therefore Woodland Outdoor Kindergartens reserves the right to charge £15 per child for every 15 minutes late in collection.

# **Medical Symptoms and Medication**

For the health and welfare of all children who come to the nursery we request that you do not bring your child into nursery if they are ill or have an infectious disease. All unexplained rashes will be treated as infectious until they have been assessed by a doctor. We reserve the right to contact you or your emergency contacts to make arrangements for you to collect your child from the Kindergarten, if staff feel that your child is not well enough to attend.

Following an infectious illness, it is essential that your child does not attend the nursery until they are no longer at risk of infecting others. If your child has had symptoms of vomiting or diarrhoea (or both), it is essential that they do not attend until 48 hours after the symptoms have stopped.

If your child is on any medication which has to be administered whilst attending the Kindergarten, you must complete a medicine consent form giving instructions on times and dosage and sign on a daily basis.

# **Acceptance of Terms and Conditions**
